

#### AMENDED ARTICLES OF INCORPORATION

OF

#### ARTICLE I

The name of the corporation is **Atlanta Tamil Mandram**, **Inc**.

#### ARTICLE II

The corporation is formed as a nonprofit corporation pursuant to the Georgia Nonprofit Corporation Code.

#### **ARTICLE VI**

The corporation is organized exclusively for cultural, charitable, educational, and scientific purposes, and for such other purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as now in effect or hereafter amended (the "Internal Revenue Code"), or the corresponding provisions of any future federal tax code. In particular, the corporation shall preserve a place to gather Tamil community people across Georgia, promote Tamil culture and language

among the Tamil-speaking population of Georgia, and to promote friendship, goodwill, and appreciation between Tamil-speaking people and various cross-sections of the people of Georgia.

#### ARTICLE VII

The corporation shall have members.

#### **ARTICLE VIII**

Dissolution section: Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of IRC §501(c)(3), or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not so disposed of shall be disposed of by the district court of the county in which the principal office of the corporation is then located, exclusively for such purposes or to such organization or organizations, as said court shall determine, which are organized and operated exclusively for such purposes. Purpose Section: The corporation is organized exclusively for charitable, educational, and scientific purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code of 1986 ("IRC"), or the corresponding section of any future federal tax code, and without limiting the foregoing, the corporation is further organized to: Preserve and promote Tamil language and to promote Tamil Culture of the entity.

#### **ARTICLE IX**

The amendment was approved by all the incorporators.

#### **ARTICLE X**
